2. Sealed competitive Bids are invited by the undersigned from the reputed/registered firm/ Vendor for **Construction of Boundary wall extension at APS Dhar Road Pre-Primary Wing** as per the scope of work attached as **Appendix 'A'** to this Tender document:
3. **Quoted Price:**
 - a) The Bidder shall quote unit rate for each item including GST. Transportation cost for supply of items should also be included.
 - b) The rate quoted shall be fixed can not be changed at later stage.
 - c) Correction if any shall be made by crossing out, initialing, dating and rewriting.
 - d) The Bidder shall deposit earnest money @ 3% of the value of contract with the bid in the form of a Demand Draft drawn in favour of, **Army Public School Dhar Road**, payable at **Udhampur**. The earnest money shall be returned to the unsuccessful bidders.
 - e) Telex or Facsimile Bids are not acceptable.
 - f) Last date for submission of bids by 1600 hr on **20 Nov 2024**. The sealed bids should be deposited/reach by the due date and time. The responsibility to ensure this lies with the bidder. Bids received beyond the time and date given above shall be rejected.

- (c) Notwithstanding the above, the Indenter reserves the right to accept or reject all Bids and to cancel the bidding process and reject all Bids at any time prior to issue of supply order.

1.	Providing and laying in position Cement Concrete of specified grade including curing. All work upto plinth level with ratio 1:3:6 (1 Cement: 3 Coarse sand : 6 graded stone aggregate). Foundation should be minimum 2 ft deep, 1.5 ft wide & 1 ft above the ground area.	Cu Ft	120	
2.	14" Wide Brick Wall: Providing and laying masonry 14" wide First Class brickwork of common burnt clay bricks (non modular) of class B designation 7.5 with 1:4 cement mortar including curing in cement mortar 1:4 (1 cement : 4 coarse sand) in 14" thickness of wall, joints raked to .5 inch clear, upto the height of 5 ft.	Sq Ft	225	
3.	Plaster on Both Side of wall : Supply & laying 12mm thick Cement plaster over entire surface other than tilling surface with cement mortar ration 1:4 (1 Cement: 4 fine course sand).	Sq Ft	360
