3. **Quoted Price:**
 - a) The Bidder shall quote unit rate for each item including GST. Transportation cost for supply of items should also be included.
 - b) The rate quoted shall be fixed cannot be changed at later stage.
 - c) Correction if any shall be made by crossing out, initialing, dating and rewriting.
 - d) Telex or Facsimile Bids are not acceptable.
 - e) Last date for submission of bids by 1600 hr on **20 Nov 2024**. The sealed bids should be deposited/reach by the due date and time. The responsibility to ensure this lies with the bidder. Bids received beyond the time and date given above shall be rejected.
 - f) The Bidder shall deposit earnest money @ 3% of the value of contract with the bid in the form of a Demand Draft drawn in favour of, **Army Public School Dhar Road**, payable at **Udhampur**. The earnest money shall be returned to the unsuccessful bidders.

1.	Fabrication & Installation of Iron Cages of size 5'x5'x6' Ht. For PVC water tank capacity 1000 Ltr., made with angle iron frame 40x40x5 mm (Four side closed frame) and fixing welded mesh net size 50x50 mm, Made of mesh wire of dia 4 mm including strengthening with 40x5 mm Iron flat complete. Iron frame size should be 2.5 feet x 3 feet every side and top. Fixing to Iron cages in cement concrete block 1:2:4 mix (1 cement : 2 coarse sand : 4 graded stone aggregate 20mm nominal size) and painting with synthetic enamel paint with primer coat and two coat black. etc. (with openable door on the top of cage).
