2. Sealed competitive Bids are invited by the undersigned from the reputed/registered firm/ Vendor for **Tiling Work inside assembly shed at APS Dhar Road Pre-Primary Wing** as per the scope of work attached as **Appendix 'A'** to this Tender document:
3. **Quoted Price:**
  - a) The Bidder shall quote unit rate for each item including GST. Transportation cost for supply of items should also be included.
  - b) The rate quoted shall be fixed can not be changed at later stage.
  - c) Correction if any shall be made by crossing out, initialing, dating and rewriting.
  - d) The Bidder shall deposit earnest money @ 3% of the value of contract with the bid in the form of a Demand Draft drawn in favour of, **Army Public School Dhar Road**, payable at **Udhampur**. The earnest money shall be returned to the unsuccessful bidders.
  - e) Telex or Facsimile Bids are not acceptable.
  - f) Last date for submission of bids by 1600 hr on **04 Jul 2024**. The sealed bids should be deposited/reach by the due date and time. The responsibility to ensure this lies with the bidder. Bids received beyond the time and date given above shall be rejected.

1.	Uprooting of the old and damaged tiles of the complete area total 4600 Sq ft lifting the Malwa upto a lead of 50 mtrs or as directed by the site Supervisor.	Sq Ft	4600	
2.	Fixing of new branded floor tiles as per the specifications and area mentioned below:  (a) Supply and laying of Anti skid good quality (ISI marked) tiles 16 Inch x 16 Inch 25 mm thickness for Assembly shed jointed with neat cement slurry mixed with pigment to match the shade of tiles, including rubbing and cleaning etc. Complete on 20mm thick bed of cement mortar 1:4 (1cement :4 coarse sand). Dark shade pigment using ordinary cement complete in all respect including sand, cement coarse aggregate and fixing charges - Area 4600 Sq ft	Sq Ft	4600	
3.	Tiles to be fixed after preparing base and levelling of surface with sand and cement and fixing them firmly.
